The dining room is open for breakfast, lunch and dinner from Monday to Friday from 22/09/2014 to 31/07/2015, holydays excluded.

The payment of tuition fees allows also: to use all the tools and common equipment (including Internet connection wi-fi) and the participation in cultural activities and lessons internal organized by the "Gregorianum".

THE UNDERSIGNED ACCEPTS ALSO THE FOLLOWING CONDITIONS:

1. Fees will be paid for the whole of the assigned period within the fifth day of each month.
2. Have read and accepted the “*Common sense guideline for community living*”.
3. In case of cancellation of stay in Padua after having paid the deposit, it will only be reimbursed in serious and attested cases (illness, accidents, etc.) and with written notification at least 15 days before scheduled arrival. Any cost of bank transfer will be on charge of the student. Otherwise the deposit will be held by “Gregorianum” as compensation. If cancellation would occur after arrival in Padua, also a two month rent will be requested in addition to the loss of the deposit.
4. The student will respect all the property, furnishings and amenities, including those of communal use. The student accepts personal and joint responsibility with the other residents for any damage to communal areas inside the building (furnishings, amenities, installations, entrance halls, corridors, stairs, recreational areas, etc.) in accordance with the criteria established in article 1588 of the Codice Civile.
5. The “Gregorianum” Direction reserves the right to carry out checks on the correct use of the property and may therefore enter rooms at any time.
6. The student will also behave correctly towards the staff and not disrupt their work.
7. The student declares not to have any infectious illnesses.
8. In the case that the student decides to leave the accommodation beforehand, for valid and documented reasons the student must inform the “Gregorianum” Direction in writing. The latter will attempt to reallocate the place, though the student will be asked to pay for the period in which the place remains unoccupied.
9. The deposit will be repaid when staff have inspected and approved the conditions of the room and communal areas, and when the student has returned the key and any other assigned items.
10. The “Gregorianum” will be accessible at all students during the whole Academic Year (except Christmas and Easter holidays).
